

**Terms and Conditions of Use  
of DATA.GOV.HK**

3. The Data are provided by the Government to you on an "AS IS" basis and for general reference only. The Data are not intended to be relied upon. No statement, representation or warranty of any kind (whether express or implied) is given by the Government in relation to the Data (including the accuracy, completeness, non-infringement, reliability, security, timeliness and appropriateness of the Data for use in any particular circumstances). The Government shall not be liable for any errors, omissions, misstatements or misrepresentations (express or implied), concerning any Data, and shall not have or accept any liability, obligation or responsibility whatsoever for any loss, destruction or damage (including without limitation consequential loss, destruction or damage) howsoever arising from or in respect of any use or misuse of or reliance on the Data, or any inability to use the Data.

4. **In consideration of the Government providing the Data on DATA.GOV.HK, by using DATA.GOV.HK, you accept unconditionally the Terms of Use. IF YOU DO NOT AGREE, DO NOT USE DATA.GOV.HK.** The Terms of Use may be revised and/or amended from time to time by the Government without prior notice to any person. Please check the Terms of Use regularly for any revisions and/or amendments which may be made.

5. The Government does not warrant or represent that **DATA.GOV.HK** or any Data transmitted from the Government to you through **DATA.GOV.HK** are free of computer viruses. You are advised to perform virus scanning before using the Data. 6. The Government shall not be responsible for any loss or damage whatsoever arising out of or in connection with the Data. The Government reserves the right to revise, omit, edit or suspend the provision of the Data at any time in its absolute discretion without giving any reason or prior notice to any person (including you). Before acting upon the Data, you should:

- make your own assessment of the Data;
- verify the Data by making reference, for example, to the original source of publications and other relevant documentation; and
- obtain independent advice from relevant professionals.

7. The Government does not undertake to provide any updated version of the Data and reserves the right to suspend the provision of the Data at any time.

### **Use of Data on DATA.GOV.HK**

8. You are allowed to browse, download, distribute, reproduce, hyperlink to, and print in their original format the Data for both commercial and non-commercial purposes on a free-of-charge basis on condition that:-

- you shall comply with the Terms of Use;
- you shall reproduce and distribute the Data accurately, fairly and sufficiently;

12. Unless otherwise indicated, the Government is the owner of the intellectual property rights in all contents available on **DATA.GOV.HK**, including but not limited to all Data.

13. The Government reserves all rights that are not expressly granted in the Terms of Use. For the avoidance of doubt, the permission given in paragraph 8 above does not extend to any Data that are contributed by a third party as identified and acknowledged in **DATA.GOV.HK**. If you intend to reproduce, distribute or otherwise use any Data that are contributed by a third party, you shall obtain all necessary authorization or permission from such third party.

## **Governing Law**

14. The Terms of Use shall be governed and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China ("Hong Kong"). You also agree to submit to the jurisdiction of the Hong Kong Courts.

## **Language**

15. The Terms of Use are translated into Chinese. If there is any inconsistency or ambiguity between the English version and the Chinese version of the Terms of Use, the English version shall prevail.

## **Priority of Terms**

16. In connection with the Data and **DATA.GOV.HK**, in the event and to the extent of any conflict between the Terms of Use and any terms or conditions applicable to the use of the website <http://www.gov.hk> ("GovHK"), the Terms of Use shall prevail over the latter.
